When used according to directions, Syringe will not harm fine turfgrass.

DIRECTIONS FOR USE: GENERAL TURF Greens, Tees, Fairways, Lawns and Sports Turf

Injection Application:

Inject 1-2 quarts or 5-10 ppm of Syringe per acre. Syringe can be applied through all injection systems. Apply monthly or as needed throughout the growing season.

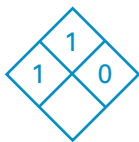
Ground Spray Equipment:

Apply Syringe at 1-2 fl.oz./1,000 sq. ft. in 2 gallons of water. Best performance will be obtained if syringe cycle is activated following application. Irrigation is required after each application to remove Syringe from the leaf surfaces. **DO NOT** combine Syringe in the spray tank with pesticides or fertilizers unless prior use has shown the combination physically compatible, effective, and non-injurious under local conditions.
